Section 2 - Hazards Identification

Emergency Overview

Physical Description & Colour: Clear, orange-yellow liquid.

Potential Health Effects

This is a pharmacologically active preparation, and contact should be avoided except for its intended veterinary use. If you have come into contact with this product, and you experience any unusual symptoms, seek medical attention.

Inhalation

Short Term Exposure: Significant inhalation exposure is considered to be unlikely. Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

Long Term Exposure: No data for health effects associated with long term inhalation.

Skin Contact:

Short Term Exposure: Available data indicates that this product is not harmful. It should present no hazards in normal use. However product may be mildly irritating, but is unlikely to cause anything more than mild discomfort which should disappear once contact ceases.

Long Term Exposure: No data for health effects associated with long term skin exposure.

Eye Contact:

Short Term Exposure: Exposure via eyes is considered to be unlikely. This product may be mildly irritating to eyes, but is unlikely to cause anything more than mild discomfort which should disappear once product is removed.

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

Section 4 - First Aid Measures

General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this MSDS with you when you call.

Self Injection: Accidental self injection may lead to an inflammatory response. Medical advice should be sought on the management of deep injections, particularly those near a joint or associated with bruising. If possible the application of gentle squeezing pressure with absorbent material (e.g. facial tissues) at the injection site will swab up unabsorbed vaccine. Strong squeezing of the site should be avoided. The damaged area should be thoroughly cleansed and a topical antiseptic applied.

Inhalation: First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

Skin Contact: Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed.

Eye Contact: No effects expected. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. Obtain medical advice if irritation becomes painful or lasts more than a few minutes.

Ingestion: If product is swallowed or gets in mouth, wash mouth with water and give some water to drink. If symptoms develop, or if in doubt contact a Poisons Information Centre or a doctor.

Advice to Doctor: If a patient reports with a recent overdose by ingestion, the stomach may be emptied by gastric lavage and aspiration. Patients should be managed with intensive symptomatic and supportive therapy. Pay particular attention to the maintenance of cardiovascular, respiratory and renal functions and to the maintenance of electrolyte balance.

Dialysis is of little or no value in poisoning by benzodiazepines or phenothiazines.

In the management of phenothiazine-induced hypotension the use of adrenaline or other sympathomimetics with beta adrenergic agonist properties should be avoided; since the alpha-blocking effects of phenothiazines impair the usual alpha-mediated vasoconstriction and these agents may exacerbate hypotension in such cases.

The management of poisoning with sedatives or hypnotics. The airway will become obstructed unless the patient is nursed in the coma position until alert enough to maintain his own airway. Central respiratory depression occurs less often with benzodiazepines than with barbiturates but combination with other central nervous system depressants has an additive if not synergistic effect. If there is a respiratory depression the patient should be mechanically ventilated. Primary respiratory acidosis may be compounded by secondary metabolic acidosis, resulting in an acidaemia the correction of which will tend to cause hypokalaemia. Aspiration pneumonitis is the other main respiratory complication, and should be prevented if possible. Hypotension should be managed initially with fluids or, if persistent, a positive inotrope such as dobutamine.

For the management of poisoning with neuroleptics, gastric lavage should be performed up to 6 hours after ingestion, and then be followed with activated charcoal treatment. The foundation of treatment is supportive care. If dystonic reactions occur, they normally respond rapidly to procyclidine 5 to 10 mg or orphenadrine 20 to 40 mg given intramuscularly or intravenously. Dantrolene is the drug of choice in the neuroleptic malignant syndrome. (J Henry and G Volans, Br. Med. J. 1984, 289:1291).

Section 5 - Fire Fighting Measures

Fire and Explosion Hazards: There is no risk of an explosion from this product under normal circumstances if it is involved in a fire.

Only small quantities of decomposition products are expected from this products at temperatures normally achieved in a fire. This will only occur after heating to dryness.

Section 6 - Accidental Release Measures

Accidental release: This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. For minor spills, refer to product label for specific instructions. No special protective clothing is normally necessary because of this product. However it is good practice to wear latex gloves when handling vaccines. In the event of a major spill, prevent spillage from entering drains or water courses and call emergency services.

Section 7 - Handling and Storage

Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Check Section 8 of this MSDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling in order to minimise risks to persons using the product in the workplace. Also, avoid contact or contamination of product with incompatible materials listed in Section 10.

Storage: This product is a Scheduled Poison. Observe all relevant regulations regarding sale, transport and storage of this schedule of poison. Store packages of this product in a cool place. Store in the closed original container in a dry, cool, well-ventilated area out of direct sunlight. Make sure that the product does not come into contact with substances listed under "Incompatibilities" in Section 10. Some liquid preparations settle or separate on standing and may require stirring before use. Check packaging - there may be further storage instructions on the label.

Section 8 - Exposure Controls and Personal Protection

Skin Protection: The information at hand indicates that this product is not harmful and that normally no special skin protection is necessary. Section 10 - Stability and Reactivity

Reactivity: This product is unlikely to react or decompose under normal storage conditions. However, if you have any doubts, contact the supplier for advice on shelf life properties.

Conditions to Avoid: This product should be kept in a cool place, preferably below 30°C. Store in the closed original container in a dry, cool, well-ventilated area out of direct sunlight.

Incompatibilities: strong acids, strong bases, strong oxidising agents.

Fire Decomposition: Only small quantities of decomposition products are expected from this products at temperatures normally achieved in a fire. This will only occur after heating to dryness. Carbon dioxide, and if combustion is incomplete, carbon monoxide and smoke. Nitrogen and its compounds, and under some circumstances, oxides of nitrogen. Occasionally hydrogen cyanide gas. Water. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death.

Polymerisation: This product will not undergo polymerisation reactions.
