6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures For minor spills: refer to product label for specific instructions. Avoid inhalation of fumes, and skin or eye contact. Absorb with an inert material and place in an appropriate waste disposal container.

In the event of a major spill: Wear appropriate personal protective equipment and clothing to minimise exposure. Increase ventilation. If possible contain the spill. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Do not dilute material but contain. 7. HANDLING AND STORAGE

Precautions for Safe Handling Used as directed on label or package insert. Avoid generating dust/vapours. Use in a well ventilated area. Exposure without protection should be prevented in order to lessen the possibility of disorders. It is essential that all who come into contact with this material maintain high standards of personal hygiene ie. washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for Safe Storage Store in a cool, dry, well-ventilated area, out of direct sunlight and moisture. Keep containers tightly closed when not in use. Keep only in original container. Store below 25°C. Do not refrigerate. Discard 15mL and 30mL pack size 6 months after initial use when stored below 25°C. Discard 3mL pack size 14 days after initial use when stored below 25°C.
